WHEREAS the Contractor desires to obtain the benefit of the services of the 1099 Employee, and the 1099 Employee desires to render such services on the terms and conditions set forth.

IN CONSIDERATION of the promises and other good and valuable consideration (the sufficiency and receipt of which are hereby acknowledged) the parties agree as follows:

1. 1099 Employment

The 1099 Employee agrees that he/she will at all times faithfully, industriously, and to the best of his skill, ability, experience and talents, perform all of the duties required of his position. In carrying out these duties and responsibilities, the 1099 Employee shall comply with all of J-SEA Services Unlimited LLC's policies, procedures, rules and regulations, both written and oral, as are announced by the Contractor and/or Contractor's MSO requirements from time to time. It is also understood and agreed to by the 1099 Employee that his assignment, duties and responsibilities and reporting arrangements may be changed by the Contractor in its sole discretion without causing termination of this agreement.

2. Position Title

As a Field Technician/1099 Employee, the 1099 Employee is required to perform the following duties and undertake the following responsibilities in a professional manner.

- (b) - Follow all MSO Installation/Removal Standards
- (c) - Follow all OSHA Safety Standards

Other duties under this position may arise from time to time, and as may be assigned to the 1099 employee, and if J-SEA Services Unlimited LLC is back charged for any of the improper procedures implemented by the 1099 employee under its contractual obligations, J-SEA Services Unlimited LLC will charge back the 1099 employee for all their responsibilities not met on each job site.

3. Compensation

- (a) As full compensation for all services provided the 1099 employee shall be paid at the starting rate of \$85 an hour and \$125 a Day Per Diem if "No" financial assistance is given to 1099 employee .
- (b) As full compensation for all services provided the 1099 employee shall be paid at the starting rate of \$85 an hour and \$125 a Day Per Diem t " if financial assistance is given to 1099 employee

- (d) The compensation mentioned in paragraph (I)(a) shall be reviewed on a weekly or Bi-weekly pay basis depending on which city and state your working in.
- (e) All expenses arising and/or interest of JSEA Services LLC shall be reimbursed thru a payroll deduction.
